To All Whom These Presents May Concern:

I, Edward W. Bedford,

the Mortgagor, SEND GREETING

WHILES the said Mortgagor is in and by these Presents, well and truly indebted to First National Bank of Greenville, hereinafter called Mortgagor, in the full and just sum of ~~\$150.00~~ DOLLARS, to be paid in monthly installments of Twenty Five (\$25.00) Dollars each, first payment on or before August 1, 1912, and continuing thereafter until paid in full, with interest thereon from date, at the rate of ~~7 1/2~~ per centum per annum, to be computed and paid monthly, until paid in full, all interest not paid when due to bear interest at the same rate of principal and any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose the mortgage, and in case said note should be issued in the hands of an attorney for sum or collection the Mortgagor agrees to pay all costs and expenses including reasonable amounts as attorneys' fees, this to be added to the mortgage indebtedness and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagor according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor paid by the said Mortgagor at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Mortgagor,

First National Bank of Greenville, its successors, forever, all that certain piece, parcel or tract of land, with all improvements thereon, or hereafter erected or built, situated in the State of South Carolina, County of Greenville, in the town of Greenville, about one-half mile west of the intersection of State Highway No. 11, (Highway connecting Greenville and Spartanburg,) and a road thereto off of the said highway, being a tract, 170 feet wide, 100 feet deep, fronting on the said highway, affixed thereto, and being bounded on the south by the said State Highway, January 27, 1912, and being a party of the above described tract, and by the said State Highway, April 19, 1912, and containing, 1/2 acre, being in Greenville County, Greenville, South Carolina, at page 325, and being bounded on the north by the property of Sam Anderson (now owned by Anderson or his wife by lease from H. C. Anderson, a soldier), on the south by other lands of H. C. and Mattie L. Bedford, and on the west by the former service road of the 300 service road, containing the following courses and distances, to-wit:

Bounding on a point in the center of the said 300 service road, joint corner of the Anderson tract, and to run with the Anderson line N. 41-00 E. 56 feet to an iron pin on the interior line; thence with the said line S. 13-55 E. 20-0-4 feet to an iron pin on the sidewalk; thence a newline, N. 3-37 W. 39-1/2 feet to an iron pin on the right side of the driveway, on road into the house of the H. C. and Mattie L. Bedford property; thence continue with the edge of said road, N. 66-23 W. 12-1 feet to a stake; thence N. 3-37 E. 10-1 feet to a stake at the bend of said road; thence N. 3-37 W. 97-1/2 feet to a joint in the center of the said 300 service road (stake back set line at 14 feet); thence with the center of the said road, N. 22-35 E. 12-1 feet to the beginning corner and containing 2 acres, more or less.

This being that same property conveyed to mortgagor by deed of H. C. and Mattie L. Bedford, dated March 16, 1905, and recorded in Deed Book 538, at page 180.
