To all Whom These Presents May Concern:

WHEREAS, I, G. F. Tucker, Jr., of Greenville County,

well and truly indebted to Lawrence F. Pearson, Jr., in the full amount of One Thousand and No/100 (\$1,000.00) Dollars and by my certain promissory note in writing of even date herewith, due and payable as follows: Twenty-Five and No/100 (\$25.00) Dollars on the first day of August, 1962, and Twenty-Five and No/100 (\$25.00) Dollars on the first day of each and every succeeding calendar month thereafter until the principal debt has been paid in full, with payments applied first to interest, and then to the remaining principal balance due from month to month, with the privilege to anticipate any or all payments on the within indebtedness at any time without penalty,

with interest from the date of this note at the rate of six (6%) per cent per annum until paid, interest to be computed and paid monthly, and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal process of any kind, reference being thereto to be fully made appear.

NOW KNOW ALL MEN That I, the said G. F. Tucker, Jr.,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents, do give, bequeath and release unto the said Lawrence F. Pearson, Jr., his heirs and assigns forever:

ALL that certain piece, parcel or lot of land, in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot No. 95 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office, for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds to-wit:

BEGINNING at a point on the eastern side of McSwain Drive at the joint front corner of Lots 94 and 95 and running thence N 67-37 E 175.65 feet to a point at the joint rear corner of Lots 94 and 95; thence S 22-10 E 95 feet to a point at the joint rear corner of Lots 95 and 96; thence S.67-37 W 175.3 feet to a point on the Eastern side of McSwain Drive at the joint front corner of Lots 95 and 96; thence with the Eastern side of McSwain Drive N 22-23 W 95 feet to the point of beginning. Being the same conveyed to me by the mortgagee by deed of even date, to be recorded herewith.

It is understood that this is a second mortgage on the above described property and is subject to a first mortgage from the mortgagor herein to William R. Timmons, Jr., in the original sum of \$1,709.18, which mortgage is to be recorded at the same time the within mortgage is recorded.

Heirs and Assigns forever. And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and defend all and singular the said premises unto the said mortgagee, his Heirs and Assigns, from and against me, my Heirs, Executors, Administrators, and Assigns and every person whomsoever, lawfully claiming, or to claim the same in any part thereof.
