NOW KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt and tor better securing the payment thereof to the Mortgagoe, and also in consideration of the further sum of Three Dolland (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release, unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of , State of South Carolina: On the Northeastern corner of Rutherford Street and Croft Street in the City of Greenville and according to a survey made by Pickell & Pickell on March 23, 1962 is described as forlows:

BEGINNING at an iron pin at the northeastern corner of Rutherford Street and Croft Street and running thence with the Eastern side of Rutherford Street, N. 1-41 E. 138.8 feet to an iron pin; thence S. 85-39 E. 197.2 feet to an iron pin on an alley; thence with the western side of said alley, S. 1-41 W. 69.3 feet to an iron pin; thence N. 85-39 W. 50 feet to an iron pin; thence S. 1-41 W. 69.3 feet to an iron pin on Croft Street; thence with the northern side of Croft Street, N. 85-39 W 2-147 feet to beginning corner.

The Mortgagor further covenants to whrfant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
