hereinafter called Mortgagee, in the full and just sum of Nineteen Hundred twenty-nine and 60/100 (\$1929.60) DOLLARS.

to be paid ten dollars each and every week, from and after July 6th, 1962, until full debt be paid,

with interest thereon from date of 7-6-⁶³ at the rate of six per centum per annum, to be computed and paid until paid in full, or interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part thereof debt.

Carl Duncan and Vernon Duncan, their heirs and assigns:-

That certain lot of land, with the improvements thereon, in Chick Springs Township, said County and State, and School District #286, and lying west from Poplar Drive and on the south side of Campbell Avenue, and having the following courses and distances, to-wit:

Beginning at an old iron pin on southern edge of said Campbell Avenue, and runs thence with said Avenue, S 89-00 E seventy-eight (78) feet to iron pin on the same line; thence a new line, S 35-00 W one hundred twenty-one (121) feet to iron pin; thence N 89-00 W sixty (60) feet to an old iron pin; thence N 1-08 E one hundred nineteen and eight-tenths (119.8) feet to the point of beginning.
