TO ALL WHOM THESE PRESENTS MAY CONCERN:

Carl W. Cobb and Jane K. Cobb
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Fifteen Thousand and no/100----** DOLLARS (\$ 15,000.00----) with interest thereon from date at the rate of **Five & three-fourths** per centum per annum, said principal and interest to be repaid in monthly instalments of **One Hundred and no/100---** Dollars (\$ 100.00) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal, and

That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Nora Drive, being shown and designated as Lot 6 of a plat of Bruce Heights, recorded in Plat Book JJ at page 5, and being further described according to said plat as follows:

BEGINNING at an iron pin on the Western side of Nora Drive at the joint front corner of Lots 5 and 6, running thence along the joint line of said lots, S. 81-36 W. 200.4 feet to an iron pin; thence N. 16-20 W. 75 feet to an iron pin; thence N. 78-00 E. 206.4 feet to an iron pin; thence along the Western side of Nora Drive, S. 10-50 E. 90 feet to the Beginning.
