NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the southwesterly side of Westbrook Lane, near the City of Greenville, South Carolina, being shown as Lot No. 11 Block C on plat of Brookforest as recorded in the RMC Office for Greenville County, South Carolina in Plat Book BB, page 41.

FOR VALUE RECEIVED Joseph C. Aldridge hereby assigns, transfers and sets over to Mr. Quentin Ball, the within mortgage and the note which the same secures to the extent of \$480.00.
