NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s)/in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the, said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain spece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick of Springs Township, being known and designated as Lot 80 of a subdivision known as Thornwood Acres, Section 2, as shown on plat thereof prepared by J. Mac Richardson, Surveyor, April, 1959, and recorded in the R. M.C. Office for Greenville County in Plat Book MM, at Page 105 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Leafwood Drive, they joint front corner of Lots 79 and 80 and running thence along the joint line of said lots, S. 53-23 E. 165 feet to an iron pin at the joint rear corner of Lots. 76 and 77; thence along the line of Lot 76, S. 2-05 W. 131.3 feet to an iron pin in the center line of a 68-foot power line right-of-way, the joint rear corner of Lots 75, 76, 80 and 81; thence along the joint line of Lots 80 and 81, N. 44-24 W. 231.6 feet to an iron pin on the southern side of Leafwood Drive; thence along the southern side of Leafwood Drive in a northeasterly direction 28.2 feet to a concrete monument; thence continuing along the southern side of Leafwood Drive, N. 36-37 E. 41.8 feet to the beginning corner; being the same property conveyed to us by Larry G. Shaw by his deed dated to be recorded herewith."

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgagee in escrow to pay said premiums, taxes and special assessments.
