cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Forty-Nine and 29/100 - - - - - - - (\$ 49.29) Dollars upon the first day of each and every calendar month hereafter in advance, until the full printipal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed, monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

ances, and then to the payment of principal. The last payment on said note, it not paid earlier and it not subsequently extended, will be due and payable 18 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (307 days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the white amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said, note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW'KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND EOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE; at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained sold and released, and by these presents do grant, bargain, sell and release unif the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

C. Jones and Associates, Engineers, dated April 1955, and a revised plat dated May 15, 1956, recorded in the R. M. C. Office for Greenville/County in Plat Book EE, at page 130, and having, according to said plat, the following metes and bounds:

"BEGINNING at an iron pin on the northern edge of Derwood Lane, the joint front corner of Lots #25 and #26, and running thence along the line of these lots, N. 41-51 W. 209 feet to an iron pin; running thence S. 64-53 W. 70 feet to an iron pin at the joint rear corner of Lots #26 and #27; running thence S. 33-29 E, 228.4 feet to an iron pin on the northern edge of Derwood Lane; running thence along the northern edge of Derwood Lane which line is curved, the chord of which is N. 52-18 E. 40.8 feet to an iron pin; thence continuing along the northern edge of Derwood Lane, N. 48-19 E. 60 feet to an iron pin, point of beginning; being the same conveyed to me by Leslie & Shaw, Inc. by deed dated July 19, 1962, to be recorded herewith."
