NOW, KNOW ALL, MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his accont by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$500) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township being mere specifically described and delineated as Lot No. 2 on a plat prepared by A. . . Ragsdale, . . . . Registered Land Surveyor No. 2303, under date of Fermary 5, 1942, same being duly of record in the office of R. M. O. for Greenville County, 3. C. in Fast Book at page which plat shows said lot as follows: Reginning at an iron pin on the southeast corner of this lot and a street, thence, north 600 west, 93 feet to an iron pin; thence, north 300 cast along the eastern boundary of Lot 4. 3 for a distance of 174 feet to an iron pin; thence, south 63°, 55 minutes cast along the line of lands of Anale S. McAbee for a distance of 93 feet to an aron pin; thence, south 29°, 56 minutes west along Lot 1 on said plat for a distance of 179.8 feet to the beginning point. The property herein conveyed is situated about two miles north of Fiedment near Groves Station in Greenville County, 3. C., and is a part of a development known as Whispering Pines. This is the same property which the mort gagor acquired from James S. Cooley by deed dated Aly 20, 1942, same to be recorded contemporaneously with this mort face.
