All that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed the constituate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, containing three agrees, more or less, on the western side of Highway. No. 14 near Mosteller's Mill, three miles north of Green, being part of Lots Nos. 9 and 10 of Marie, M. Burnett Estate "Mill Tract", and having the following courses and distances:
