And said mortgagor agrees to keep the building and improvements now standing or bereafter erected upon the mortgaged premises and any and all apparatus, fixtures and apputenances, now or hereafter in or attached to said buildings or improvements insured against loss or damage by fire and such other hazards as the mortgagee may from time to time feequire, all such insurance to be in forms, in companies and in sums (not less than sufficient to avoid any claim on the part of the insurers for consurance) satisfactory to the mortgagee; that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the mortgagee, that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the mortgagee, and that at least fifteen days before the expiration of each such policy, a new and sufficient policy to, take the place of the one so expiring shall be delivered to the mortgage. The mortgage feetby assigns too the mortgagee all moneys recoverable under each such policy, and agrees that in the event of a loss the amount collected under any policy of insurance on said property may, at the option of the mortgage, else applied by the mortgage por any portion thereof may, at the option of the mortgage citter be used in replacing, repairing or restoring the improvements partially or totally destroyed to a condition satisfactory to said mortgagee, or be released to the mortgagor in cither of which events the mortgagee shall not be obligated to see to the proper application thereof; nor shall the amount so released or used, be deemed a payment on any indebt claess secured hereby. The mortgagor hereby appoints the mortgage attorney irrevocable of the mortgagor to assign each such policy in the event of the foreclosure of this mortgage. In the event the mortgagor may on such failure declare the debt due and institute foreclosure proceedings.

And in case proceedings for foreclosure shall be instituted, the mortgagor agrees to and does hereby assign the rents and profits arising or to arise from the mortgaged premises as additional security for this loan, and agrees that any Judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the mortgaged premises, with full authority to take possession of the premises, and collect the rents and profits and apply the net proceeds (after paying costs of receivership) upon said debt, interests, costs and expenses, without liability to account for anything more than the rents and profits actually received.

PROVIDED ALWAYS, nevertheless, and it is the true intent and meaning of the parties to these Presents, that if the said mortgager, does and shall well and truly pay or cause to be paid unto the said mortgage the debt or sum of money aforesaid with interest thereon, if any he due a cording to the true intent and meaning of the said note, and any and all other sums which may become due and payable thereunder, the estate hereby granted shall cease, determine and be utterly null and void; otherwise to remain in full force and virtue.

AND IT IS AGREED by and between the said parties that said mortgagor shall be entitled to hold and enjoy the said Premises until default shall be made as herein partied.

The covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors, and assigns of the parties hereto. Whenever used the singular number shall include the plural, the plural the singular, the use of any gender shall be applicable to all genders, and the term "Mortgagee" shall include any payee of the indebtedness hereby secured or any transferre thereof whether by operation of law or otherwise.
