do hereby make and confess my true intent and meaning, on signing of even date with these presents, to am well and truly convey to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just

sixty-six hundred fifty and no/100-- (\$6,650.00) dollars,

with interest at the rate of six per cent per annum, to be repaid in installments of

Fifty-six and 13/100-- \$ 56.13 Dollars upon the first day of each and every calendar month thereafter until the full principal sum with interest has been paid. Said monthly payments to include six per cent of interest, computed monthly on the unpaid balance, and thereafter to bear interest at six per cent per annum, provided that if at any time any portion of the principal or interest shall become due and unpaid for a period of thirty (30) days; or failure to comply with any of the terms and conditions herein or the stipulations of this mortgage, the whole amount due under and after such date at the option of the holder thereof, become immediately due and payable, which may sue and recover the same by action, suit, or otherwise, further providing for a ten per cent attorney's fee besides all costs for collection, and to have and hold the amount due on said note, and to be collectible, as a part thereof, if the said holder shall cause to be made a collection or at said debt, or any part thereof, be collected by attorney, or other proceedings, or legal call of which is secured under this mortgage; as in and by said note, and as hereinafter appears.
