TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the Northern side of Crescent Avenue, formerly Mills Avenue, known and designated as lot No. 9 of Block B on plat of Cagle Park Land Company, recorded in Plat Book C at Page 238 in the R.M.C. Office for Greenville County, and being further described according to said plat as follows:

BEGINNING At an iron pin on the Northern side of Crescent Avenue, formerly Mills Avenue, at the joint front corner of lots Nos. 9 and 10 running thence along the line of lot No. 10, N. 8-42 W. 162.6 feet to an iron pin at the corner of lots Nos. 38 and 37; thence along the line of lot No. 38, N. 89-07 W. 78 feet to an iron pin at the corner of lot No. 8; thence along the line of lot No. 8, S. 12-09 E. 172.8 feet to an iron pin on the Northern side of Crescent Avenue; thence along Crescent Avenue, N. 82 E. 67 feet to the point of beginning.
