Mauldin Construction Co., a South Carolina corporation with its principal place of business in Greenville, S. C.

SEND GREETINGS:

WHEREAS, I, we the aforesaid mortgagor(s) in and by my our certain promissory note, in writing, of even date with these presents am are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENVILLE

VILLE, in the full and just sum of Twelve Thousand, Five Hundred & No/100 - (\$ 12,500.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of

Ninety-Four and 78/100 - - - - - (\$ 94.78) Dollars, upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 18 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and enforce this mortgage; said note further providing for ten (10%) per centum attorney's fees beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I, we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me (as the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

C. Jones, C. E., April, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book YY, at page 73, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Swanson Court, joint front corner of Lots Nos. 18 and 19, and running thence along the joint line of said lots, N. 20-20 E. 200.8 feet to an iron pin; thence continuing along the joint line of said lots, N. 20-20 E. 15 feet, more or less, to a point in the center of Richland Creek; thence along the center of Richland Creek as the line, the traverse lines being N. 53-06 W. 85.4 feet and N. 67-18 W. 45 feet, to a point in said creek, the northwest corner of Lot No. 19; thence S. 14-55 W. 25 feet, more or less, to an iron pin; thence along the same course, following the rear line of Lot No. 20 for a portion of the distance, S. 14-55 W. 233.7 feet to an iron pin on the northern side of Swanson Court; thence along the northern side of Swanson Court, following the curvature thereof, the chord of which is S. 73-10 E. 105.7 feet, to the beginning corner, being the same conveyed to the mortgagor corporation by J. H. Mauldin by deed of even date, to be recorded herewith."
