DOLLARS (\$ 11,000.00, to be paid

Six (6) months after date

with interest thereon from date

at the rate of Five and One Half (5½) percentum per annum, to be computed and paid until paid in full; all interest not paid when due to bear interest at the same rate as principal.

And if any portion of principal or interest be at any time past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note(s) become immediately due at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ten (10%) per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

BEGINNING at an iron pin on the South side of Forestdale Drive at joint front corner of Lots 45 and 46 and said fence with the line of Lot 45, S. 4-31 E. 121.30 feet to an iron pin; thence N. 35-45 W. 90 feet, to an iron pin in the rear line of Lot 47; thence through Lot 47, N. 4-31 E. 121.30 feet to an iron pin on the Southside of Forestdale Drive in the front line of Lot 46; thence along Forestdale Drive S. 35-29 E. 50 feet to beginning corner.
