TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Two Thousand and no/100 DOLLARS (\$2,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Twenty-nine and no/100 Dollars (\$29.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, situate on the western side of Hughes Road, being shown as lot No. 5 on a plat of the property of J. C. Hughes, made by J. C. Hill, August 1959, recorded in the RMC Office for Greenville County in Plat Book SS at Page 136, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Hughes Road, at the joint front corner of lots Nos. 4 and 5, and running thence with the western side of Hughes Road, S. 15-40 W. 205.9 feet to pin; thence S. 78-10 W. 15.3 feet to pin on branch; thence with the branch as the line N. 14-30 W. 143.8 feet to pin; thence continuing N. 30 W. 127.8 feet to pin at the rear corner of lot No. 4; thence with line of lot No. 4, S. 89-25 E. 183.6 feet to pin on Hughes Road, the point of Beginning.

Said premises being the same conveyed to the Mortgagor by deed recorded in Vol. 700 at Page 23.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
