- (3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever feneirs are necessary, including the completion of any construction work hadderway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- (4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or impositions againt the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.

- (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgage, all sums then owing by the Mortgage to the Mortgage shall become immediately due and payable, and this mortgage impy be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgage become a party of any authority of collection by suit or otherwise, all costs and expenses incurred by the Mortgage, and a reasonable attorney for, all the tempor become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.

  (7) That the Mortgager shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured bereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
