(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor, in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee or successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on Palham Street in the City of Greer, being shown and designated as Lot No. 2 on plat of property of the M.H. Jones Estate, said plat prepared by H.S. Brockman, Surveyor, dated September 30, 1939, and having the following courses and distances, to-wit:

BEGINNING on a stake on the east side of Pelham Street, on property edge of street curb, corner of Lot No. 1, and runs thence with line of Lot No. 1, S. 56-57 E. 226.9 feet to a stake on line of Lot No. 1, and corner of Lot No. 5; thence with line of Lots Nos. 4 and 5, N. 3-24 W. 82.8 feet to a stake, corner of Lots Nos. 2 and 3; thence with line of Lot No. 3, N. 60-32 W. 177.8 feet to a stake on east side of Pelham Street; thence with Pelham Street, S. 33-03 W. 55 feet to the beginning corner.
