And in case proceedings for foreclosure shall be instituted, the mortgagor agree **B** to and does hereby assign the rents and profits arising on to arise from the mortgaged premises as additional security for this loan, and agree **B** that any Judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the mortgaged premises, with full authority to take possession of the premises, and collect the rents and profits and apply the net proceeds (after paying costs of receivership) upon said debt, interests, costs and expenses, without liability to account for any more than the rents and profits actually received.
