WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the south side of Dellwood Drive, in the City of Greenville, being shown as lot 41, on a plat of a subdivision of a portion of lots 18 and 19, Essex Court, recorded in Plat Book DD at Page 165, and described as follows:

BEGINNING at an iron pin on the south side of Dellwood Drive, joint front corner of lots 40 and 41, and running thence through an iron pin, S. 1-39 E. 182.7 feet to center of creek; joint rear corner of lots 40 and 41; thence with center of creek as the line, S. 89-43 W. 75 feet to joint rear corner of lots 41 and 42; thence with line of lot 42, N. 1-33 W. 174.2 feet to pin on the south side of Dellwood Drive; thence with said drive, N. 83-06 E. 75 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by deed recorded in Book of Deeds 494 at Page 330.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
