All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 16 on plat of property of O. V. Hunt Estate recorded in plat book XX page 15 of the RMC Office for Greenville County, S. C., said lot having a frontage of 119 feet on the north side of Avery Street, a depth of 123.67 feet on the west side, a depth of 128.4 feet on the east side, and a rear width of 119.1 feet.
