MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, WE, ANNE E. & DOROTHY GENTRY

(hereinafter referred to as Mortgagor) is well and truly indebted unto DELTA CONSTRUCTION COMPANY, INC.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWO THOUSAND THREE HUNDRED TWENTY FIVE and no/100

Dollars (\$ 2,325.00) due and payable at the rate of \$37.50 per month for 60 consecutive months, commencing on the 1st day of October, 1962 and the 1st day of each month thereafter until the entire balance is paid in full.

With interest thereon from date of the note at the rate of 6% per annum, to be paid without interest until such time as the entire balance is due and payable, from thence at 7% per annum.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sum for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and that is situated in or let off in Greenville Township, Greenville, County, South Carolina on the Old Easley Bridge Road about 4½ miles, South West of the City of Greenville, containing one acre or more or less. Beginning at a point in the center of the old Easley Bridge, and at corner of property now or formerly of L. V. Alexander, in front of entrance of the Arkansas line North S-40 East 40 feet to a stone wall, and from said wall go still with the Alexander line North S-40 East 40 feet to a tree, and from the tree of the 40 feet, thence with the line of the road to the right to a fence post, thence parallel with the line of the road to the left 40 feet, and from said post to the left, Old Easley Bridge Road, a distance of 40 feet to the end of said fence, Old Easley Bridge Road, thence with the center of said road with 40-46 feet to the left to the point of beginning.
