

Tract 6, 732-34 and 736-38 Hollywood Street;

All that lot or parcel of land in the City of Spartanburg, South Carolina, located on the North side of Hollywood Street and the West side of Scenic Drive; known as the front (Southern) 150 feet of Lots Nos. 27 and 28, Block C-2 on plat of amended survey made April 1, 1928, by H. Stribling, C. E., entitled "Connecticut Heights, Property of Connecticut Heights Land Co." recorded in Plat Book 27, at page 273, R. M. C. Office for Spartanburg County.

Tract 7, is located in UNION COUNTY, SOUTH CAROLINA
N. W. Corner N. Pinckney & Sharp St. Union, S. C.

All that certain piece or parcel of land in Union County, State of South Carolina, lying in the City of Union at the north-west corner of Sharp and North Pinckney Streets, fronting on said North Pinckney St., (Formerly Virgin St.) ninety-two and one-half (92½) feet, and running back west along Sharp Street, one hundred forty-eight and one-half (148½) feet, and being bounded on the north by lands of Purcell, on the east by North Pinckney Street, and on the south by Sharp Street (sometimes called Sharp's Alley) and on the west by lands of Union-Buffalo Mills Company, and being the same property conveyed to Carolina Scenic Stages by deed of Claude W. Tract 8, is located in YORK COUNTY, SOUTH CAROLINA
N. E. Corner Oakland & Black Street, Rock Hill, S. C.

All that certain piece, parcel or lot of land with erected buildings now used as a Bus Station and all other improvements thereon, situated in the corporate limits of the City of Rock Hill, County of York, State of South Carolina, at the north-eastern corner of the intersection of Oakland Avenue and Black Street, and having the following courses, distances, metes and bounds, to-wit:
