NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the west side of Trotter Street (formerly Hunt Street, and having the following metes and bounds, to-wit:

BESENNING at an iron pin on the west side of Trotter Street, at corner of lot heretofore conveyed to B. B. Smith, and running thence along his line N. 55-30 W. 150 feet to an iron pin; thence N. 33-35 E. 50 feet, more or less, to an iron pin in line of lot 1 of the C. E. Briscoe property; thence along the line of that lot, S. 55-30 E. 150 feet to joint corner of that lot with the west side of Trotter Street; thence along the line of said Trotter Street, S. 33-35 W. 50 feet, more or less, to beginning, which is approximately 250 feet from Pendleton St.
