cured hereby), said note to be repaid with interest at the rate specified therein in installments of

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before, the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property to with following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 4 according to a plat of property of Maggie Mae Lampe Gancedo as shown on plat thereof prepared by W. J. Riddle, Surveyor, May, 1949 and recorded in the R. M. C. Office for Greenville County in Plat Book II, at page 183, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of U.S. Highway No. 29 at the joint Front corner of Lots 3 and 4, and running thence along the joint line of said lots, S. 84-52 W. 162 feet to an iron pin in the right-of-way line of the C. & G. division of Southern Railroad; and running thence along the line of said right-of-way, S. 19-40 E. 77 feet to an iron pin at the joint rear corner of Lots 4 and 5; thence with the joint line of said lots, N. 84-52 E. 137.3 feet to an iron pin on the western side of said U. S. Highway No. 29, joint front corner of Lots 4 and 5; thence with the western side of said highway, N. 0-08 W. 75 feet to the point of beginning; being the same conveyed to us by Maggie Mae Gancedo by deed dated March 8, 1962 and recorded in the R.M.C. office for Greenville County in Deed Vol. 693, at page 548."

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgagee in escrow to pay said premiums, taxes and special assessments. Should these payments exceed the amount of payments actually made by the mortgagee for taxes, assessments, or insurance premiums, the excess may be credited by the mortgagee on subsequent payments to be made by the mortgagor (s); if, however, said

sums shall be insufficient to make said payments when the same shall become due and/payable, the mortgagor (s) shall pay to the mortgagee any
