MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, B. L. Farr and Janet Farr, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Eight Thousand, Six Hundred and no/100 (\$8,600.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of

Sixty-Five and 21/100 (\$ 65.21 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 18 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee, beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate; lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one and one-half miles south from Taylors, South Carolina, lying on the western side of the road that leads from Taylor's to Brushy Creek Baptist Church, being bounded on the north by lot of Leonard A. and Margaret S. Smith, on the east by the said road and on the south and west by other lands of C. S. Hammett and having the following courses and distances, to-wit:

"BEGINNING on a nail and stopper in the center of the said road, joint corner of the Smith lot, and runs thence with the Smith line, S. 57-15 W. 280 feet to an iron pin, joint corner of the Smith lot; thence a new line, S. 20-30 W. 200 feet to a stake, new corner; thence N. 57-15 E. 280 feet to a nail and stopper in the center of the said road (iron pin back on line at 29.2 feet); thence with the center of the road, N. 19-45 W. 100 feet to a bend; thence N. 21-15 W. 100 feet to the beginning corner, containing one and twenty-six one-hundredths (1.26) acres, more or less; and being the same conveyed to us by C. S. Hammett by deed dated July 18, 1953, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 486 at page 16."
