NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate on the northeastern side of Pine Knoll Drive in Chick Springs Township, being shown as lot 3 on a plat of the property of Eloise M. Bailey, Section 1, made by Dalton & Neves, Engineers, dated May 1961, and described as follows:

BEGINNING at an iron pin on the northeastern side of Pine Knoll Drive, at the joint front corner of lots 3 & 4, said iron pin being located N, 41-00 W. 355 feet along Pine Knoll Drive from the line of property now or formerly belonging to A. M. Payne and Martha J. Payne, and running thence N. 43-15 E. 150.7 feet to an iron pin; thence S. 41-00 E. 51.4 feet to an iron pin on the western side of a proposed unnamed street; thence along said side of said proposed street S. 18-46 W. 111.2 feet to an iron pin; thence continuing along said side of said proposed street S. 33-53 W. 29.8 feet to an iron pin; thence with the curve of the intersection of said proposed street with Pine Knoll Drive, the chord of which is N. 86-00 W. 35.3 feet, to an iron pin on the nor theastern side of Pine Knoll Drive; thence along said side of Pine Knoll Drive, N. 41-00 W. 75 feet to an iron pin, the beginning corner.
