

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN



WHEREAS,

(hereinafter referred to as Mortgagor) is well and truly indebted unto DELTA CONSTRUCTION COMPANY, INC.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of ONE THOUSAND FIVE HUNDRED EIGHTY EIGHT and 60/100 Dollars (\$ 1,518.60) due and payable

at the rate of 6 1/2% per month for 30 consecutive months, commencing on the 1st day of December, 1962 and the 1st day of each month thereafter until the entire balance is paid in full

with interest thereon from date at the rate of xxxxxxxx per annum, to be paid without interest until such time as the entire balance is due and payable, from that date at 7% per annum.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GEORGE, all that certain piece, parcel or lot of land in the Town of Millville, George County, South Carolina, and particularly shown and designated as Lot 28 on a plat entitled a Subdivision for C. Cooper of Co. Inc. June 30, 1962, records in office of Clerk of Court in said county in plat Book N, page 14 and having these metes, bounds and courses as hereinafter set out on said plat appear, the lot accords to 54.5 feet on the north side of Farmer Street for a distance of 54.5 feet.
