AND IT IS FURTHER COVENANTED, That in the event the mortgagor, its successors and assigns, do not keep said property and all equipment, appurtenances and accessories in proper repair and condition as hereinbefore specified, then the mortgagee or its assigns, may have the necessary repairs made and the cost
