C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, of hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about two miles south of Taylors, S. C., lying on the west side of the Berry Road, and being a part of the same land that was conveyed to Incile Annie Kluge by deed from H. K. Kluge May 1th, 1952, recorded in the office of the R. M. C. for Green-ville County in Deed Book 477 at page 374, and having the following courses and distances, to wit:-

BECINNING on a nail and cap in the said Berry Road at S. 24-00 E., 25 feet from the corner in the said Berry Road, the same being the joint corner of the S. T. Moore tract, and runs thence S. 24-00 E., 45 feet to an iron pin on the western bank of the Said Berry Road, then continueing with the same course for a total distance of 160 feet to an iron pin on the S. T. Moore line; thence a new line, S. 66-00 W., 157.4 feet to an iron pin on the Morris Smith line; thence with the said line, N. 19-07 W., 13h.5 feet to an iron pin on the said line; thence another new line, N. 56-00 E., 148.2 feet to the beginning corner, (iron pin back on line at 18 feet), containing Fifty One One-hundredths (0,51) of One acre, more or less.
