TO ALL WHOM THESE PRESENTS MAY CONCERN: G. G. Williams

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100 DOLLARS (\$ 10,000.00 ), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred and No/100 Dollars (\$100.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee, at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township on the Northern side of Crestfield Road a short distance North of White Horse Road about 5 miles from the City of Greenville as shown on plat recorded in Plat Book AA at Page 141 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Crestfield Road at the corner of property of Sexton; thence with the line of Sexton's property, N. 3-30 W. 576.5 feet to an iron pin and stone; thence with the property of Sherman, S. 87-10 E. 174.8 feet to iron pin and stone; thence N. 2-50 E. 536 feet to an iron pin and stone; thence S. 72-42 E. 334.4 feet to an iron pin and stone; thence S. 3-18 W. 647.8 feet to an iron pin and stone on Crestfield Road; thence with said road as follows: S. 47-12 W. 109.6 feet to an iron pin; thence S. 43 W. 190 feet to an iron pin; thence S. 51-38 W. 235.9 feet to point of beginning.
