WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Thirteen Thousand Nine Hundred and No/100ths-----**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **in Greenville County, State of South Carolina, Chick Springs Township, located at Paris, South Carolina, and lying on the North side of Lee Road, being bounded, now or formerly, on the North by lot of E.W. Montgomery, on the East by lot of Mrs. Dithers, on the South by said Lee Road and on the West by other lands of Luther Alexander and having the following courses and distances, to-wit:**

BEGINNING at an iron pin on the North side of said Lee Road at 6.2 feet from pavement of said road, and running thence with Mrs. Dithers line N. 10-45 E. 241.6 feet to old iron pin on E.W. Montgomery line; thence with this line S. 75-54 W. 96.7 feet to iron pin on said line; thence S. 14-38 W. 190.6 feet to iron pin on North side of Lee Road at 6.2 feet from edge of pavement of said road; thence with the North edge of said road S. 73-47 E. 100 feet to beginning corner.
