SEND GREETING:

WHEREAS, I the said Bernice Hart

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Nine Hundred and no/100 - - - (\$ 900.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Schilleter property, and having the following courses and distances, to-wit:

BEGINNING on a stake on the south side of a new 20 foot street, being the joint corner of Lots Nos. 45 and 46, and runs with the common line thereof S. 5-45 W., 145 feet to a stake, joint corner of Lots 43 and 44; thence with the common line of these lots in a westerly direction 150 feet to a stake on the east side of said street; thence with the said street N. 5-45 E., 85 feet to a stake at the intersection of streets; thence N. 73-38 E., 150 feet to the beginning corner.
