C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Nine Thousand and no/100

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 135 on plat of Coleman Heights, recorded in plat book KK at page 29, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Alta Vista Circle at the corner of Lot 137, and running thence along said Circle, S 88-48 W, 150 feet to an iron pin; thence N 2-10 W, 149 feet to an iron pin; thence N 87-37 E, 105.4 feet to an iron pin; thence N 79-15 E, 44.6 feet to an iron pin; thence S 1-02 E, 165.5 feet to the point of beginning and being the same property conveyed to me by deed of Stanley I.
