WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Buckingham Road in the City of Greenville being shown as Lot 225 on a plat of Section B, Gower Estates, recorded in Plat Book XX at Pages 36 and 37 and being more fully described as follows:

BEGINNING at an iron pin on the northwestern side of Buckingham Road at the corner of Lot 224 and running thence with the northwestern side of said road N. 49-47 E. 130 feet to iron pin at corner of Lot 226; thence with the line of said lot N. 51-52 W. 176.3 feet to iron pin; thence S. 60-51 W. 85 feet to iron pin at corner of Lot 224; thence with the line of said lot S. 36-47 E. 189.3 feet to the beginning corner.
