(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Eight Thousand Five Hundred and No/100 - - - - -

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the making and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township situate at the Southeastern corner of the intersection of Stoneybrook Drive and Wilmington Road being shown and designated as Lot No. 156 on Plat of Section 3 of Botany Woods recorded in Plat Book RR at Page 37 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Stoneybrook Drive at the joint front corner of Lot Nos. 156 and 171 and running thence with the line of Lot No. 171, S. 46-13 E. 139.7 feet to pin at the corner of Lot No. 157; thence with the line of Lot No. 157, N. 38-47 E. 157.2 feet to pin on Wilmington Road; thence with the Southwestern side of Wilmington Road, N. 53-43 W. 136 feet to pin; thence with the curve of the intersection of Wilmington Road and Stoneybrook Drive, the chord of which is S. 72-50 W. 33.1 feet to pin; thence with the Eastern side of Stoneybrook Drive, S. 29-24 W. 115 feet to the point of beginning.
