Margaret C. Watson, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, Chick Springs Township, and being more particularly described as Lot No. 173 on a plat of property entitled "Subdivision of Greer Mill Village, Greer, S.C.," made by Dalton & Neves, January, 1951, revised July, 1952, recorded in the R.M.C. Office for Greenville County in Plat Book GG, page 15. According to said plat the within described lot is also known as No. 12 Connecticut Avenue and fronts thereon 68.5 feet.

This is the same property conveyed to the mortgagors by W. Dennis Smith by deed recorded in the R.M.C. Office for Greenville County.
