E. L. Craigo, his heirs and assigns forever,

ALL that piece, parcel or tract of land in Greenville Township, Greenville County, being known and designated as Lot No. 12 on plat of property of Harry H. Palm according to plat made by W.J. Riddle, May 1946 and recorded in Plat Book B, at page 84.
