TO ALL WHOM THESE PRESENTS MAY CONCERN:

PRESTON CHARLIE BLACKSTOCK AND MARGARET BLACKSTOCK

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Six Thousand Seven Hundred and no/100**

DOLLARS (\$ 6,700.00.....), with interest thereon from date at the rate of **six & one-half** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 66 of the Hillhouse Tract of Colonia Co., in plat book G at page 112, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Franklin Road at the corner of Lots 65 and 66, which point is approximately 330 feet north of the intersection of Hilltop Avenue, and running thence along the western side of Franklin Road, N 46-03 E, 60 feet to an iron pin at the joint corner of Lots 66 and 67; thence N 41-45 W, 350 feet to an iron pin; thence S 46-03 W, 60 feet to an iron pin at the rear corner of Lot 65; thence S 41-45 E, 350 feet to the point of beginning and being the same property conveyed to us in deed book 538 at page 434.

There is another mortgage executed by Preston Charlie and Margaret Blackstock to Travelers Rest Federal Savings & Loan Association, dated July 28, 1960, recorded in mortgage book 831, page 437, in the sum of \$17,000.00, covering the above property and another tract. These two mortgages shall be of equal rank. A default under either mortgage will constitute a default under both mortgages.
