until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including ten per cent of the indebtedness as attorney's fee, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land with any improvements thereon, situate, lying and being at the northwestern corner of the intersection of Jacob Road and Cashmere Drive in Pine Hill Village, Gaunt Township, Greenville County, South Carolina, shown and designated as Lot 6 on a plat of Pine Hill Village, prepared by R. K. Campbell, R.L.S., dated November 30, 1960, and recorded in the Office of the R. C. C. for said County and State in Plat Book 40, Page 169, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the northern side of Jacob Road, joint corner of Lots 5 and 7, and running thence N. 10-09 E. 139.2 feet along the corner of said Lots; thence S. 72-39 E. 75 feet along the joint line of Lots 6 and 29 to an iron pin on the western side of Cashmere Drive, joint corner of said Lots; thence S. 3-10 W. 104.2 feet along the western side of said Drive to an iron pin; thence around a curve at the northwestern corner of said intersection, the chord of which curve is S. 50-46 W., 33.5 feet, to an iron pin on the northern side of Jacob Road; thence N. 80-58 W. 60 feet along the northern side of said Road, to the point of beginning.
