to be paid in monthly installments of \$ 66.62 commencing on the 13 day of May, 1963 and on the 13 day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not paid sooner, shall be due and payable on the 13 day of April, 1973.

with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain parcel or lot of land situated on the southwestern side of Carolina Avenue in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 20 of Development No. 2, Victor Monaghan Co. of J.P. Stevens & Co. Inc. Greer Platn, according to survey and plat thereof by Dalton & Neves, Engineers, dated April, 1947, recorded in Plat Book "p", page 119, R.M.C, Office for Greenville County, and havin the following courses and distances, to wit:
