NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, and being known and designated as Lot No. 145 of Plat 5 of Pleasant Valley as shown on a plat thereof recorded in the R. P. C. Office for Greenville County in Plat Book "11", at Page 128 and covering, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of Prosperity Court and Prosperity Avenue and running thence around the curve of said Court, the chord of which is S. 02°40' W. 75 feet to an iron pin at the joint front corner of Lots Nos. 143 and 145; thence S. 07°15' W. 112.7 feet to an iron pin; thence N. 01°15' E. 5.3 feet to an iron pin; thence along Prosperity Avenue N. 02°00' E. 112.4 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
