I, C. S. MACLIN

SEND GREETING:

Whereas I, the said C. S. Maclin
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to Franklin Finance & Loan Company, a
Corporation in the full and just sum of Nineteen Hundred Twenty and No/100 (\$1920.00) Dollars
to be paid at the rate of \$80.00 per month, commencing
May-10, 1963 with a last and final payment on April 10, 1965

with interest thereon from maturity
at the rate of 7 per cent per annum, to be computed and paid semi-annually
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its
