reference, in the sum of **Six Thousand and no/100-**

DOLLARS (\$ 6,000.00), with interest thereon from date at the rate of **six & one-half** per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Paris** Mountain Township, containing **1 acre**, more or less, and having the following metes and bounds, to-wit:

Beginning at an iron pin in the center of Patrol Club Road, at the corner of Norwood Hester, approximately 1,100 feet northeast of Parker Road, thence N 43-30 W, 212.52 feet to an iron pin; thence along R. O. Hudson, N 43-30 E, 212.52 feet to an iron pin; thence along Ansel Bridwell, S 43-30 E, 212.52 feet to the center of Patrol Club Road; thence with said road, S 43-30 W, 211.2 feet to the point of beginning and being the same property conveyed to Ford R.
