W. B. Locke and Ella Mae Locke
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Three Thousand Five Hundred and no/100-----**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, located at the Southwestern intersection of Ackley Street and Skyland Drive, and being designated as Lot 4 on a plat of Skyland Park Subdivision, recorded in the RMC Office for Greenville County, in Plat Book L at page 41, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Ackley Street, corner of Lot 3, running thence along the Southern side of Ackley Street, N. 64-24 E. 25 feet to an iron pin corner of Ackley Street and Skyland Drive; thence S. 72-16 E. 36.4 feet to an iron pin on the Southwestern side of Skyland Drive; thence with the Southwestern side of said Drive, S. 28-56 E. 125.6 feet to an iron pin, corner of Lot 5; thence with the line of said lot, S. 64-24 W. 59 feet to an iron pin, corner of Lot 3; thence with the line of said lot, N. 25-36 W. 150 feet to the point of Beginning.

Being the same property conveyed to mortgagors by deed recorded in Deed Book 292 at page 16.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
