TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Herbert C. Mason and Pearl E. Mason, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Hundred DOLLARS (\$ 1500.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as thereth stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements hereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township in the City of Greer, located on the north side of Carey Avenue, being all of Lots Nos. 6-J and 6-I on a plat of property made for the W.C. Smith estate by H.S. Brockman, Surveyor, May 25, 1936, and being all of that property conveyed to the mortgagors by Woodrow C. Phillips by deed dated June 14, 1954, recorded in the R.M.C. Office for Greenville County in Deed Book 503, page 267, and having the following courses and distances:

BEGINNING at a stake on the north side of Carey Avenue, the southeastern corner of the lot, and runs thence along Carey Avenue N. 67-25 W. 125.5 feet to a stake; thence N. 24-25 E. 185 feet to a stake; thence S. 65-20 E. 42.5 feet to a stake; thence S. 1-30 W. 183 feet to the beginning corner.
