TO ALL WHOM THESE PRESENTS MAY CONCERN: Lewie L. Bates, Jr., Martha Ann Bates Mace, and South Carolina National Bank of Charleston, as Trustee under the Will of L.L. Bates (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **TWENTY TWO THOUSAND FIVE HUNDRED AND NO/100THS-** - - - - - **DOLLARS (\$ 22,500.00** ), with interest thereon from date at the rate of **five and one-half** per centum per annum, said principal and interest to be repaid in monthly instalments of **ONE HUNDRED FIFTY FIVE AND NO/100THS-** - - - Dollars (\$ 155.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Laurens Road in the City of Greenville and according to a plat made by Dalton & Neves in March 1963 is described as follows:

BEGINNING at an iron pin on the southwestern side of Laurens Road 288.7 feet northwest from Ackley Road at the corner of property of Conger Realty Company and running thence with the line of said property S. 64-35 W. 250 feet to an iron pin; thence N. 23-25 W. 63 feet to an iron pin; thence N. 64-35 E. 218.4 feet to an iron pin on Laurens Road; thence with the southwestern side of said Road S. 55-46 E. 72.8 feet to the beginning corner.

Being a portion of the property conveyed to L. L. Bates by deed recorded in Deed Book 166 at Page 518 and by him devised to the South Carolina National Bank as Trustee for Lewie L. Bates, Jr. and Martha Ann Bates Mace by his Will filed as Apartment 707 at File 7; the said Lewie L. Bates, Jr. and Martha Ann Bates Mace join in the execution of this mortgage to signify their consent and approval of its execution.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
