TO ALL WHOM THESE PRESENTS MAY CONCERN:

H. I. Elrod and Ethel G. Elrod (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and no/100----- DOLLARS (\$10,000.00---), with interest thereon from date at the rate of Five & three-fourths per centum per annum. Said principal and interest to be repaid in monthly installments of Eighty Three & no/100----- Dollars (\$83.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, Greenville County, on Harding Drive, and being shown on a plat of the property of O. B. Godfrey and Helen T. Godfrey, recorded in Plat Book MM at page 196, and having the following metes and bounds according to a survey and plat made by C. C. Jones, January 12, 1956:

BEGINNING at an iron pin on the Southwestern side of Harding Drive, at the corner of other property now or formerly of J. A. Fletcher, and running thence S. 31-21 W. 200 feet to an iron pin; thence S. 15-31 E. 100 feet to an iron pin; thence S. 34-37 E. 100 feet to an iron pin; thence N. 31-21 E. 200 feet to an iron pin on said Harding Drive; thence with Harding Drive, N. 34-37 W. 100 feet to an iron pin; thence N. 15-31 W. 100 feet to the Beginning.

Being the same property conveyed to the Mortgagors by deed of Atlantic School of Electronics, Inc., etc., recorded in Deed Book 722 at page 388.
