MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Edward E. White SEND GREETINGS:

WHEREAS, I the said Edward E. White

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just sum of ELEVEN THOUSAND SEVEN HUNDRED & no/100--- (\$11,700.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of

Eighty-three and 83/100--- (\$ 83.83) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid. Said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a ten per cent attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible, as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said Edward E. White

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me the said

Edward E. White in hand well and truly paid by the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side of DuVernet Drive near the city of Greenville, being shown as Lot No. 37 on plat of Section A of Mansfield Park, made by Piedmont Engineering Service, December, 1960, revised June, 1962, recorded in the R. M. C. Office for said County in Plat Book XX, page 53, and having according to said plat the following metes and bounds, to-wit: Beginning at an iron pin on the west side of DuVernet Drive at joint front corner of Lots Nos. 36 and 37, and runs thence with the line of lot No. 36, S.87-41 W.162 feet to an iron pin, thence along the line of Lot No. 42, S.13-10 E.108.7 feet to an iron pin; thence along the line of Lot No. 38 N.78-46 E.142.2 feet to an iron pin on the west side of DuVernet Drive; thence with the curve of DuVernet Drive (the chord being N.1-31 W.85 feet) to the beginning corner. This being the same property which was conveyed to Talmer Cordell by Wm. R. DuVernet et al by deed recorded in the said office in Deed Book 720, page 335. And being the same property which was conveyed to mortgagor herein by Talmer Cordell by deed dated June 27, 1963, which deed will be recorded forthwith in the said office.
