TO ALL WHOM THESE PRESENTS MAY CONCERN:

MILTON T. BARBREY

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Three Hundred and no/100

DOLLARS (\$7,300.00), with interest thereon from date at the rate of six & one-half per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, near Simpsonville, S. C., shown as the southern portion of Lot 2 on plat of property of J. M. Lattimer, recorded in plat book FF at page 408, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Richardson Street Extension, which iron pin is 360 feet southwest of the intersection of Cox and Richardson Streets, at the corner of Lot 1, thence with the line of said Lot, N 1-50 E, 99 feet to an iron pin at the corner of property heretofore conveyed in deed book 484 at page 153; thence along said property, N 73-30 W, 90 feet to an iron pin in the line of Lot 3; thence S 1-50 W, 145 feet to an iron pin on the northern side of Richardson Street; thence with said Street, N 75-30 E, 90 feet to the point of beginning and being the same property conveyed to me in deed book 596 at page 215.
